Products as such are not subject to a registration. Substances and Mixtures with subject to approval are not used. We confirm the marketability of all our products regarding REACH regulation.

Our products do not release any chemicals intentionally, nor do they contain substances placed on the SVHC candidate list for authorization, so-called substances of very high concern. Our products comply with the requirements of Annex XVII, to limit values mentioned therein and do not contain any substances forbidden therein.

Our products do not contain any substances, mixtures or products listed in Annex I and/or II of POP-Regulation 2019/1021/EU.

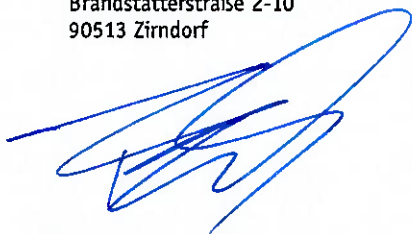
RoHS. Our products also comply with thresholds regulated under RoHS Directive 2011/65/EU (ROHS II) and 2015/863/EU).
